## **Organisational Background**



The Women Voice Against GBV – Nyeri Chapter (WVA-GBV) (we can coin a good acronym) is a national non-profit women's rights organisation in Kenya founded in the year 2018 as a response to amplify women voices in addressing all forms of Violence Against all gender but more so, against Women and Girls (VAWG).

WVA-GBV is committed to advancing women's rights and work towards achieving a society free from all forms of VAWG. The origin of WVA-GBV is traced to a workshop organized by Centre for Rights Education and Awareness (CREAW), to sensitizen

We have a wide network of multi-sectoral partnerships that enables us to offer a wide range of complementary services as well as widen reach and impact. For instance, we have partnered with St. Mary's Resuce and Nursing home /caritas and County Government of Nyeri.

# 2. OUR STRATEGIC DIRECTION Strategic Areas of Focus

In keeping with the global agenda of elimination of violence against women and girls, we have defined our organizational priorities based on five areas that constitute key elements of women and girls' empowerment organized under the following five strategic focus areas/pillars:

# **Primary Prevention**

WVA-GBV engages the public and community in creating awareness on Gender Based Violence through various Behavioral Change Communication (BCC) interventions, such as development and dissemination of target friendly BCC materials, public barazas (public

forums that engages community members), trainings, school-based activities and campaigns. Target groups include: Most at Risk

Populations, school children, adolescents and adult women and men; community members; service providers (health workers, teachers, and police officers), private sector agencies, Faith-Based Organizations, National and County Administrations.



Since its inception, WVA-GBV has focused on the maxim of 'amplifying women voices against Gender Based Violence. We have succeeded in moving the issue of WVA-GBV from the private to the public domain, positioning it as a crime and a human rights violation. Over the years, WVA-GBV has invested in empowering women and girls to claim their rights, enabling equitable access to services, resources and opportunities; facilitating greater access to justice for survivors of Sexual and Gender Based Violence (SGBV); and supporting change agents opposed to and committed to eradication of all forms of Gender Based Violence. WVA-GBV's interventions deliberately address norms, attitudes, laws, policies and practices that affect women and girls' safety and wellbeing in general. This is done through fostering consistent engagement with different actors to prevent and respond to Gender Based Violence and to hold perpetrators of these violations accountable. Our key stakeholders are the community, civil society, government and the private sector.



WVA-GBV adopts the United Nations International Declaration on Elimination of Violence Against Women (DEVAW). Article 4 of the UN Declaration defines Violence Against Women and Girls as any act of Sexual and Gender Based Violence that results in, or is likely to result in physical, sexual and psychological harm or suffering to women, includ-

ing threats of such acts, coercion or arbitrary deprivation of liberty, whether occurring in private or public life. Building upon



norms, systems and structures that deter women girls safety, equal and rights and wellbeing. WVA-GBV works with and supports vulnerable and marginalised women and girls, rural and indigenous women, special interest groups as well as women and girls' at risk of being left at the peripheries of advancement, in Nyeri



County.

#### **Our Track Record**

WVA-GBV has been at the forefront of championing for change in



the criminal justice response to SGBV survivors, especially young girls in Nyeri County. In this regard, WVA-GBV successfully advocated for sentization and dialogues. The measures include hearing such court cases in camera, provision of intermediaries to victims, allowance of more time during hearings, placement in a witness box and support towards building the capacity of the criminal justice actors. This campaign has been bearing fruits. WVA-GBV also successfully advocated for gender progressive laws, policies as well as establishment of institu-

tions. In this regard WVA-GBV lobbied for establishment of Gen-

der Desk at Mukurwe-ini Police Station, Karatina Police Station and still lobbying for other stations within the county. WVA-GBV contributed to formulation of Nyeri County Gender Policy through CREAW. WVA-GBV launched the "Justice for SGBV



survivors." campaign in June 2023 that sought justice for a woman in Karatina was brutally murdered by her husband and has been voicing out cases
